Councillor Anthony Alford kindly attended our meeting.

He praised Askerswell and advised he would be happy to go and look at Hembury to see if there is something that can be done about the potholes.

He advised there will be better information about what the Council is doing. There is a Parish Council news feed which we receive that will feed through further information which might be of use.

Dorset council have worked more with Healthcare and Volunteers in recent times.

With regard to major events, there has been over 7000 responses to the consultation. Legislation has said that the local plan needs to be completed by 2024. Planning policy purposes there will be no changes to Askerswell.

Regarding the Climate and Ecology policy, Dorset Council have received a grant from Central Government of GBP19million to change the ways we use power, to decarbonise. For example in leisure centres, pools will be heated by air pumps.
